

Among these, PLINK has chosen the **Cyber Command** platform, which detects and identifies IT threats to respond immediately and automatically to the attacks. This is possible by **monitoring internal network traffic**, correlating existing security events (with AI), and analyzing behavior. Cyber Command tests passively, seamlessly, analyzing mirrored traffic from core switches.

Because Cyber Command integrates network and endpoint security solutions, the ability of the administrator to navigate and understand the overall threat landscape is remarkable, and response is streamlined, as well as automatic. The result of the analysis is presented in an interactive dashboard, usable via a web interface, with both technical and decision-making logics.

DScan is a 100% Italian technology and is a guarantee of solidity, efficacy and safety.

CYSR - External Threat Analysis

In collaboration with our partner NetOrange, we have identified some products suitable for responding to corporate security needs and legislative compliance. They provide organizations with **complete visibility** into the security of their computing environments.

Among these, the **External Threat Analysis** service of the CYSR platform stands out, which performs an IT security risk assessment providing a complete view of the potential dangers.

By analyzing and combining key data, the platform generates an assessment from the point of view of the **external exposure of services and information** that can be the target of attacks.

After that, possible related assets are automatically inferred and a map of the probable attack surface exposed to the Internet is generated. Therefore, checks are carried out on the whole area to detect critical situations and specific vulnerabilities for each type of asset.

Once each asset has been evaluated, an algorithm calculates its rating by identifying vulnerabilities and potential risks and comparing the data obtained with those of similar companies.
